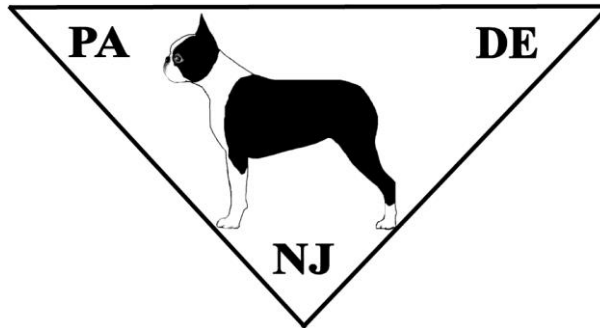

\*\* **Bred By Exhibitor Class Eligibility:** All dogs entered in the Bred By Exhibitor Class must be individually registered with the AKC. The person handling the dog must be a breeder of record of the dog and an owner of record of the dog. To exhibit in this class family members must be a breeder and owner of record.

**NON-REGULAR CLASSES INVOLVING SINGLE DOG ENTRIES**

*The first-place winners in the Veterans classes which have been undefeated in any other class will be eligible for Best of Breed Competition. (Classes for both Dogs & Bitches). At an independent breed specialty show when there is no competition beyond Best of Breed, a dog or bitch that is 7 years or older and has been spayed or neutered may compete.*

**Classes not eligible to complete for Best of Breed**

**Brace** - A brace shall be two Boston Terriers that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in brace competition must have identical ownership. The fee for the brace shall be \$16 if both dogs are entered in the Regular or Veterans Classes. Dogs not entered in regular classes may be in the Brace, but must indicate "Brace Only" on the Entry form with full particulars of the dog. The fee shall be \$16 for each dog entered as "Brace Only". If a dog is entered in another class, please indicate "Brace: in the Additional Class field. If an owner has more than 1 brace please indicate Brace #1, Brace #2, etc. Dogs may not be switched between braces.

**Team** - A Team shall be four Boston Terriers that are similar in appearance, performing in unison, and presented by a maximum of four handlers. Both dogs competing in TEAM competition must have at least one owner in common. The fee for the brace shall be \$16 if both dogs are entered in the Regular Classes. Dogs in the Team must be entered in a Regular or Veterans class. If owners have more than 1 Team please indicate Team #1, Team #2, etc. Dogs may not be switched between Teams.

**Stud Dog Class** – This class shall be for stud dogs and 2 of their get. While the merits of the stud dogs are not to be considered in the placement of the entry, they must be still examined to determine if they any condition that would require disqualification or excusal under the Dog Shows Rules, the breed standard or AKC policy. The merits of the get shall be judged. The entry fee shall be \$16 for the Stud Dog; no additional fee for the get.

**Brood Bitch Class** – Requires shall be the same as in the Stud Dog Class.

**Best Bred-by-Exhibitor** - selected each day from the winners of the 2 Bred-by-exhibitor Classes and awarded after Best of Breed

**Best Veteran and BOS Veteran** - selected each day from the winners of the 4 Veterans Classes and awarded after Best of Breed

Each DAY is A benched show All dogs must arrive by 11:00 A.M. Dogs Will Not be excused during  
 benching hours (8:30 A.M. - 5:00 P.M. Saturday & 3:30 P.M. Sunday) they are not permitted to  
 leave the building e.g. if a breed has completed judging at 9:00 A.M. the dogs are required to go to  
 the benching area for the remainder of the day and be available to meet the public. A bench audit  
 will be conducted. Once inside the building during show hours, no dog may exit until after 5:00 P.M.  
 on Saturday or 3:30 P.M. on Sunday. Dogs present must be on their assigned benches, except for the  
 necessary periods when they are actually being prepared for showing, or are being shown, or are in  
 the exercise pen, or are being taken to or from these places. This will be enforced! Violations of this  
 notice will be subject to action by the Event Committee, which may result in cancellation of the dog's  
 winnings and subject the owner or handler to further action by the American Kennel Club. building  
 Access: exhibitors may enter the building until 11:00 P.M. The building will be locked between the  
 hours of 11:00 P.M. and 6:00 A.M. each night. No one will be allowed access to the building during  
 these hours. between 5:00 P.M. and 11:00 P.M. Saturday, dogs may be removed for exercising with  
 proper identification. Security guards will be on duty. On Saturday and Sunday, admission stub for  
 each dog must be surrendered upon entrance to building and remaining stub upon exit. This will be  
 enforced both days. All dogs must enter and exit through exhibitors' entrance. surrender of  
 identification card must be made to the check clerk for removing dogs from the show.

## NOTICE TO EXHIBITORS

**ENTRY FEE** \$35.00 for the first entry of each dog (including \$.50 AKC recording fee & \$3.00 AKC Event Service Fee) except Puppy Classes (6-9 & 9-12 mos.) which are \$25.00 each, and \$20.00 additional entry of the same dog. Sweepstakes Classes and Jr. Showmanship, \$12.00.

**CLOSING DATE** for entries 12:00 NOON, WEDNESDAY, November 1, 2017 (at Show Secretary's Office) after which entries cannot be accepted, cancelled, or substituted except as provided for in Chapter 11, Section 6 of the Dog Show Rules.

**THE SHOW** will be open from 8:00 A.M. to 5:00 P.M.

An **AKC RECORDING FEE** of \$.50 and an **AKC Event Service Fee** of \$3.00 will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial, or Tracking Test. If a dog is entered in more than one class in any of these events, the AKC Recording Fee & Service Fee is to be collected on the first entry only. (AKC Rules Applying to Dog Shows, Chapter 11, Section 2). All recording fees are paid to the AKC.

**RETURNED CHECKS** do not constitute a valid entry fee. A charge of \$35.00 will be made for each returned check. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY basis.

**TELEPHONE & UNSIGNED ENTRIES CANNOT BE ACCEPTED.**

**ENTRY FEES** shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Show Committee. If because of riots, civil disturbances, or other such acts beyond the control of the management it is impossible to open or complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, must be considered for the health and safety of the dogs, exhibitors, & spectators. The well-being of dogs, exhibitors, & spectators is of paramount importance, and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

**ERRORS ON ENTRY BLANKS.** Owner are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

**NO REFUND FOR DUPLICATE ENTRIES.** We will make every effort to find all duplicate entries, but if a dog has been processed, no refund will be made.
